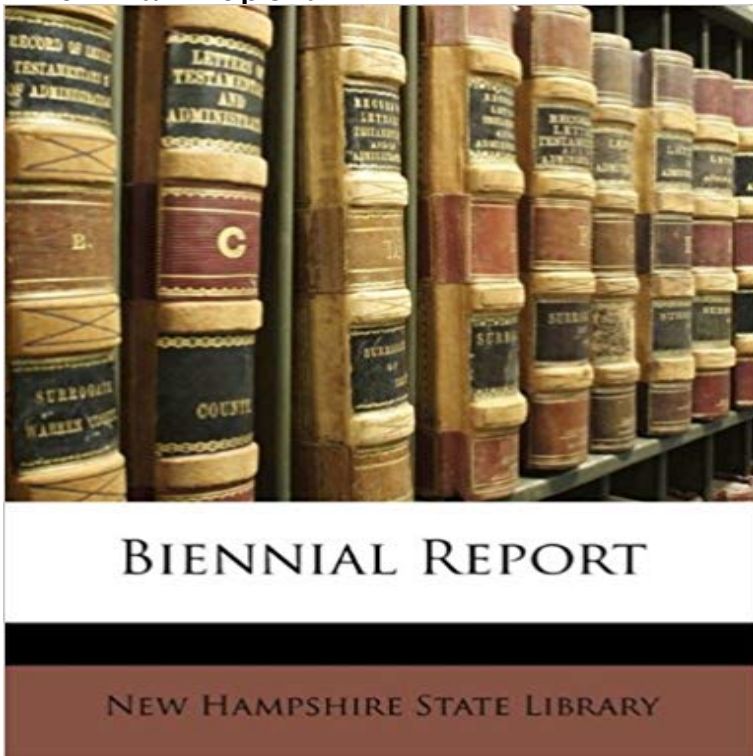


# Biennial Report
