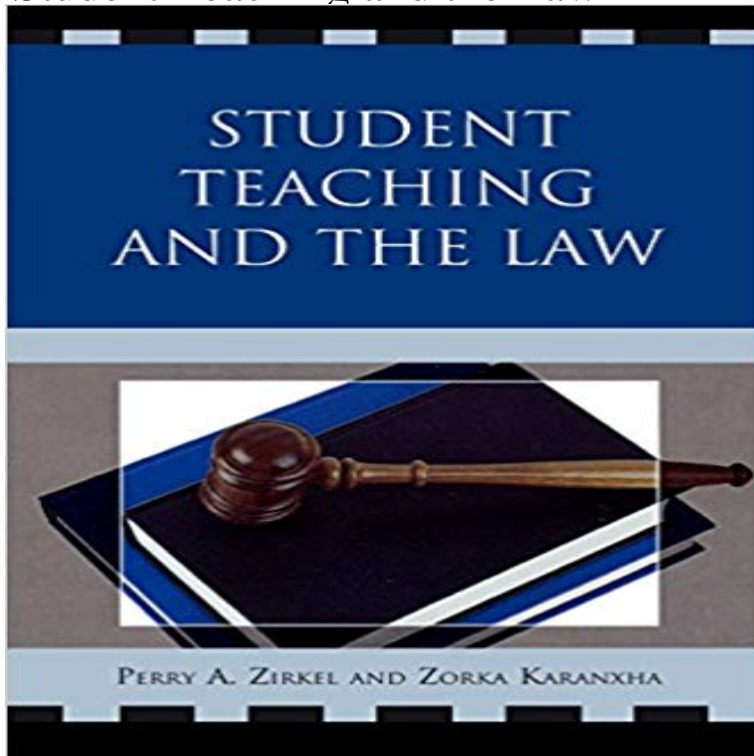


Student Teaching and the Law
