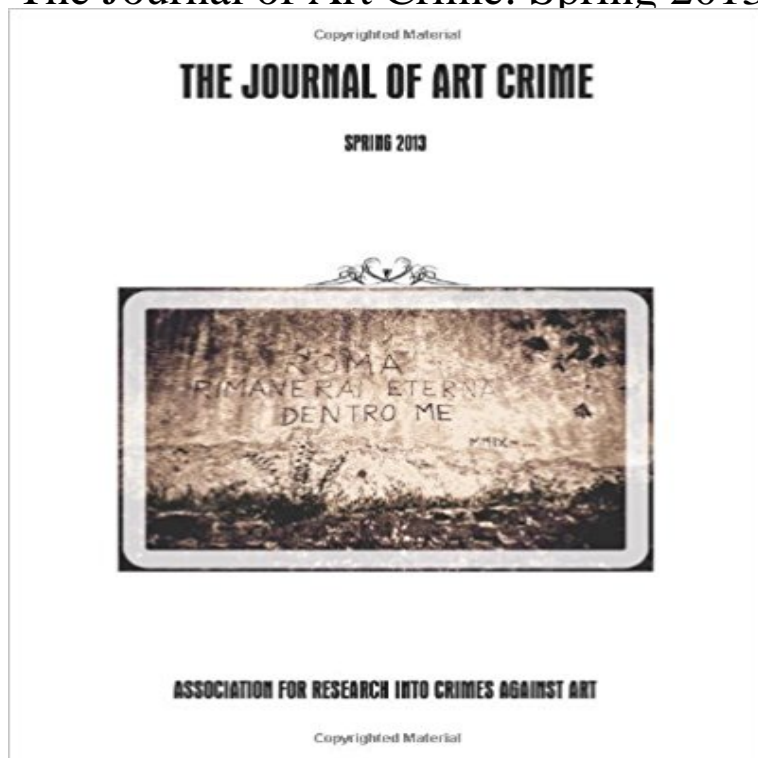


## The Journal of Art Crime: Spring 2013 (Volume 9)
