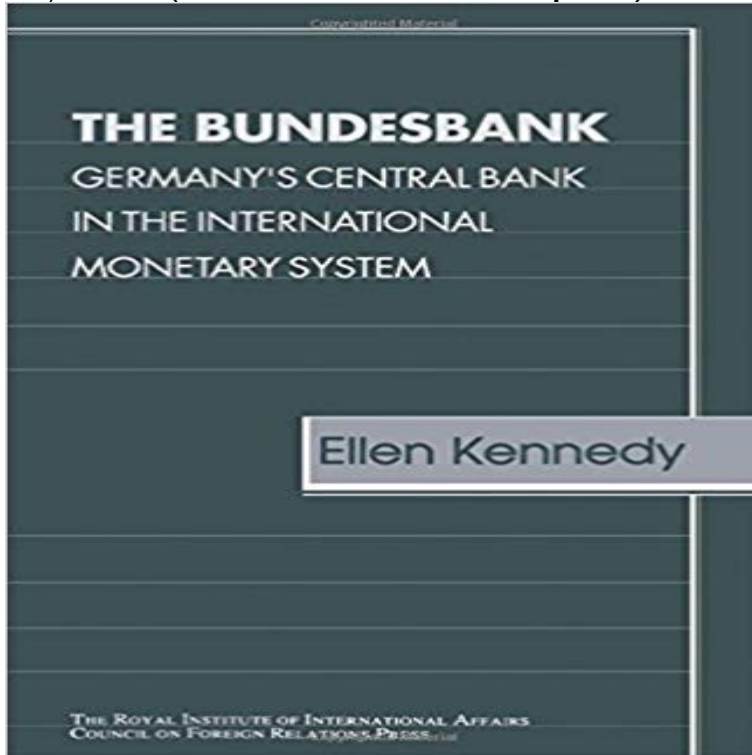


Bundesbank CFR: Germanys Central Bank in the International Monetary System (Chatham House Papers)
