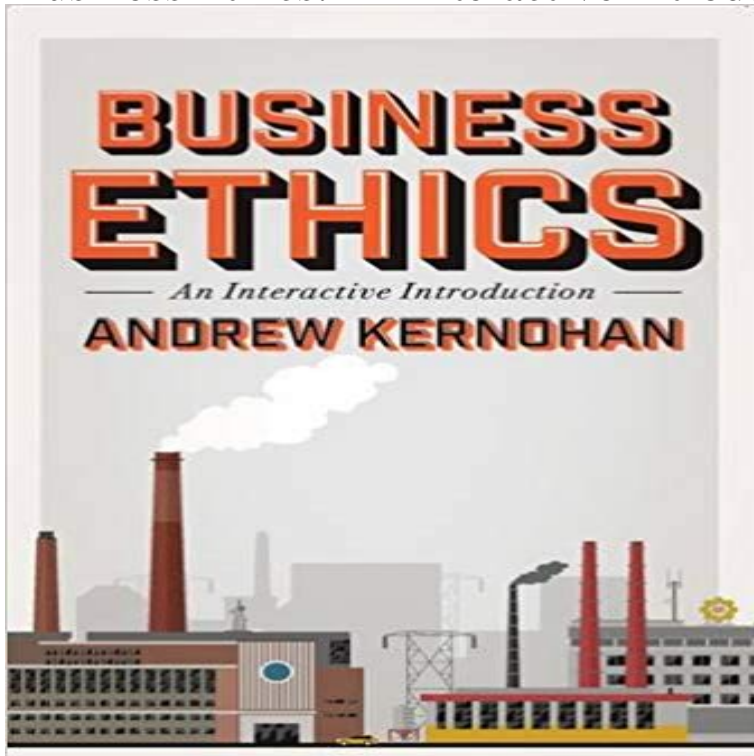


Business Ethics: An Interactive Introduction
