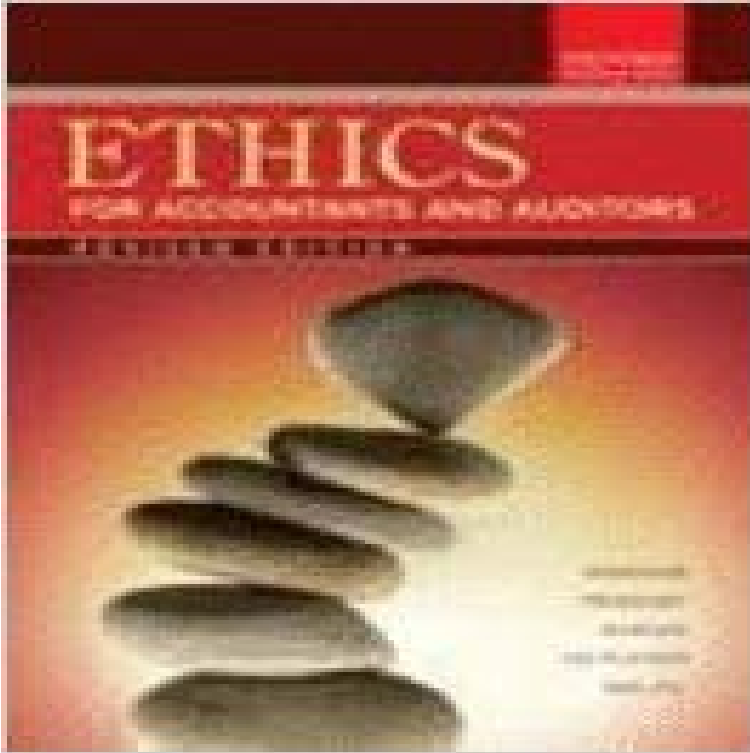


Ethics for Accountants and Auditors, Revised Edition
