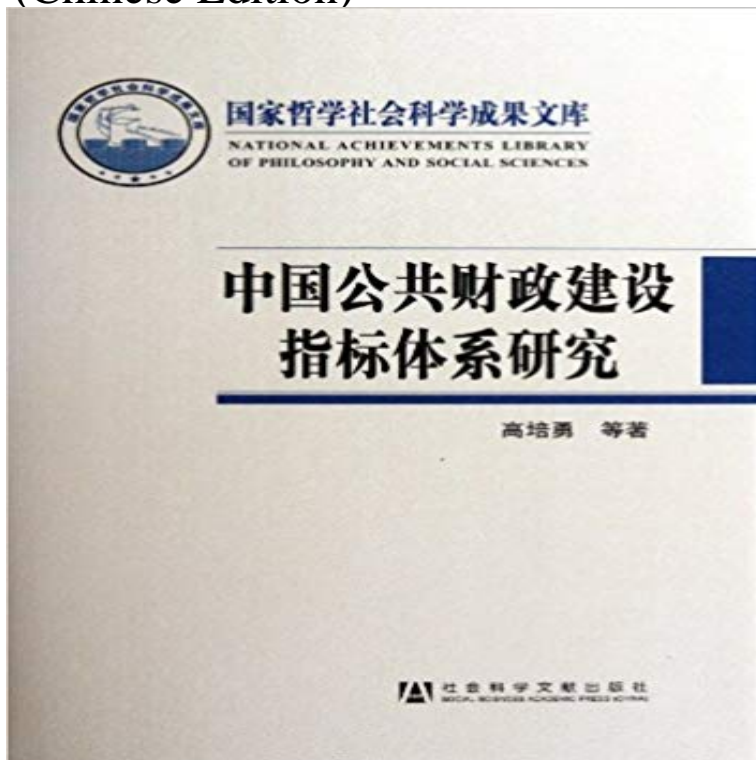


Construction of Chinese Public Finance: a study of the index system (Chinese Edition)
