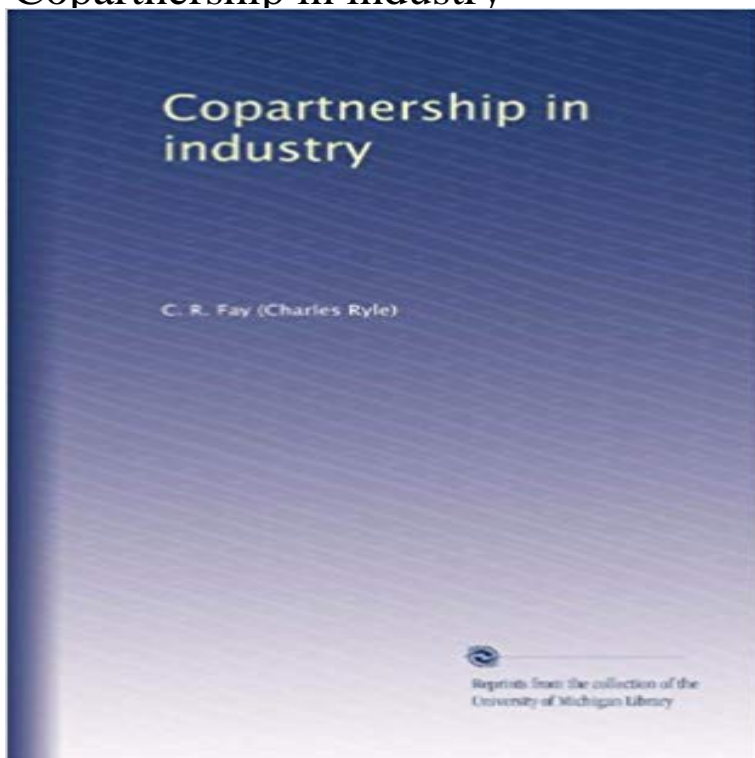


Copartnership in industry
