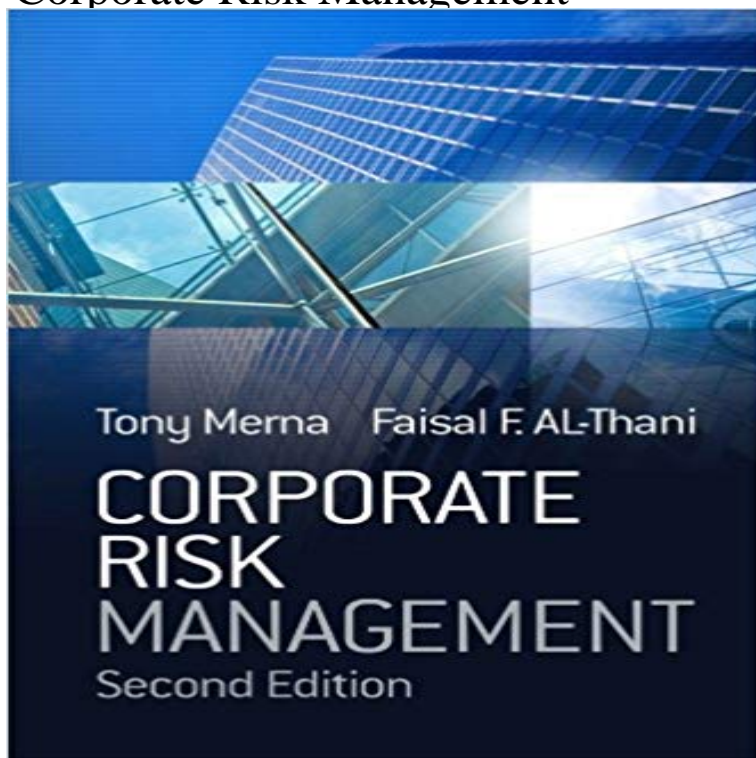


Corporate Risk Management
