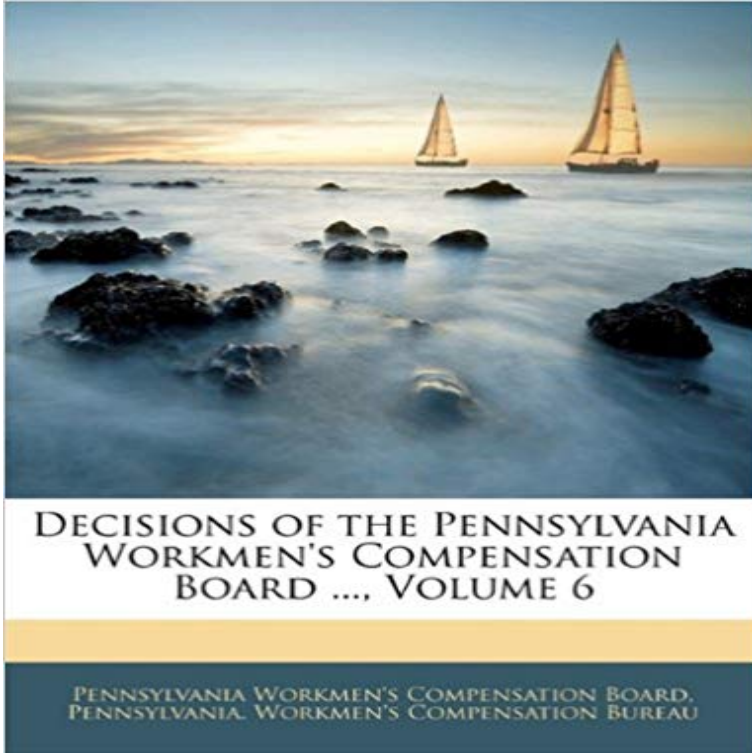


# Decisions of the Pennsylvania Workmens Compensation Board ..., Volume 6
