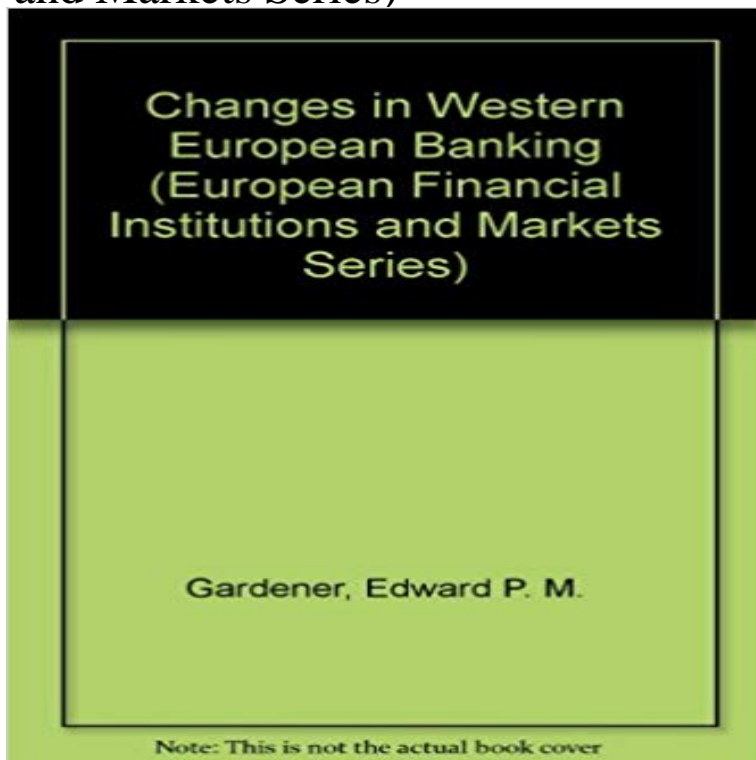


Changes in Western European Banking (European Financial Institutions and Markets Series)
