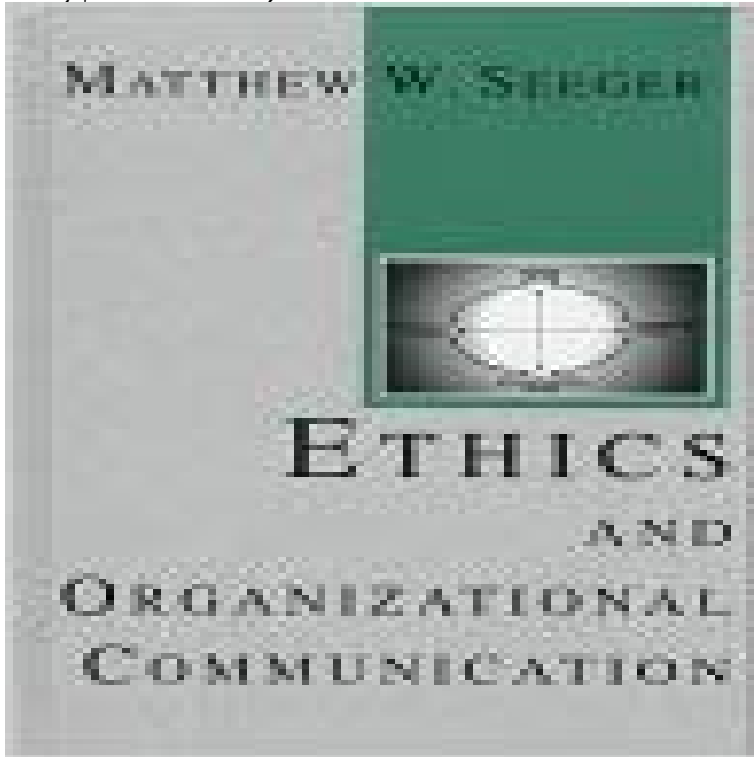


Ethics and Organizational Communication (Communication and Social Organization)
