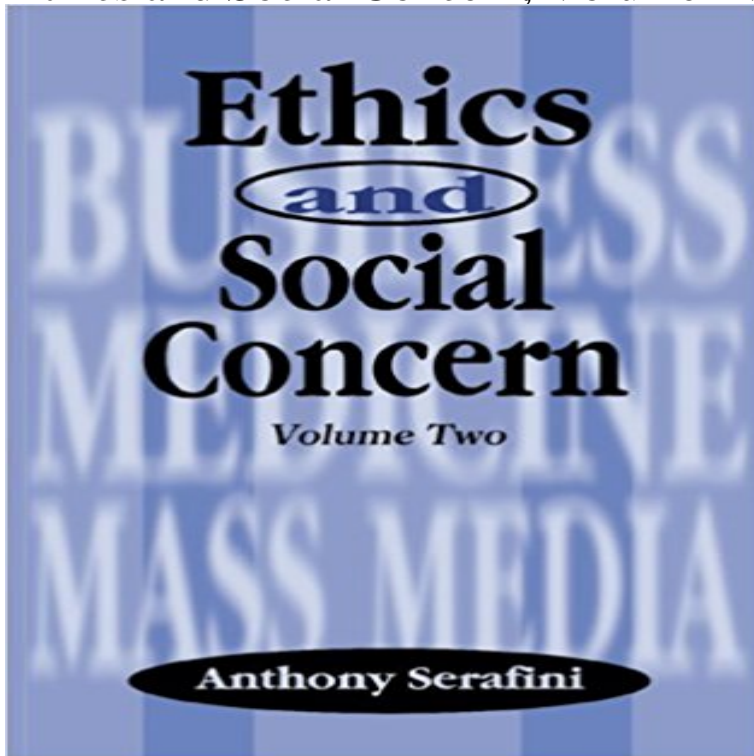


Ethics and Social Concern, Volume Two (Ethics & Social Concern)
