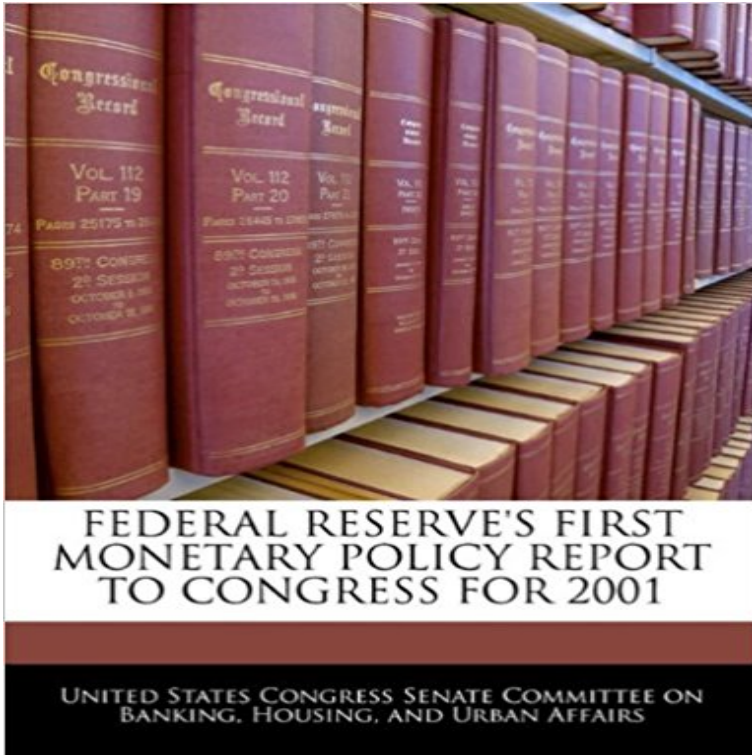


FEDERAL RESERVES FIRST MONETARY POLICY REPORT TO CONGRESS FOR 2001
