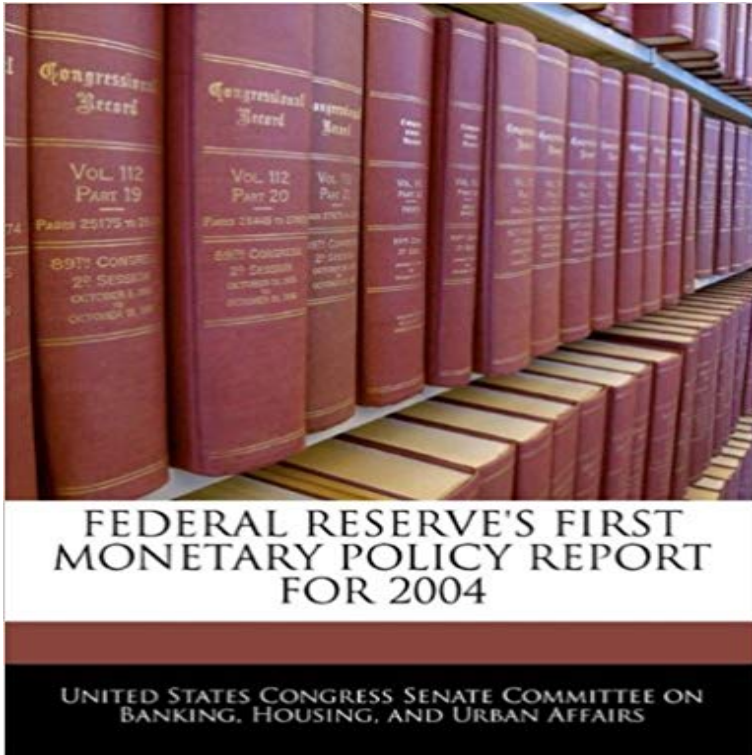


# FEDERAL RESERVES FIRST MONETARY POLICY REPORT FOR 2004
