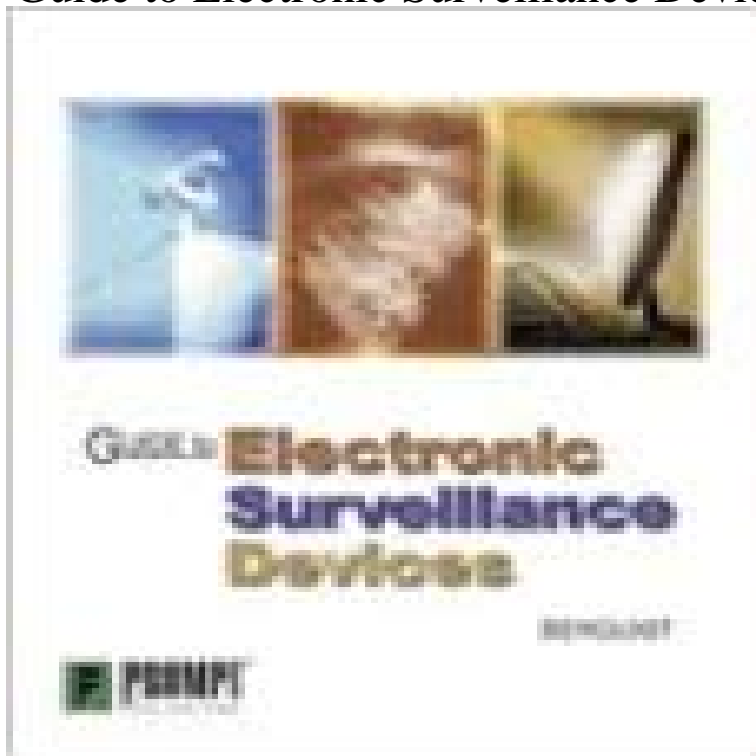


Guide to Electronic Surveillance Devices
