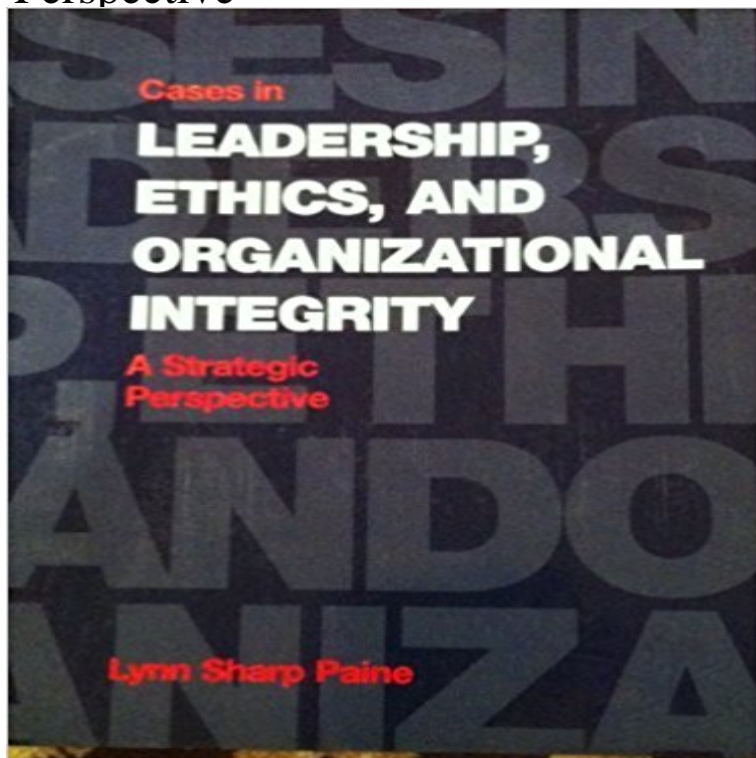


# Cases In Leadership, Ethics and Organizational Integrity: A Strategic Perspective
