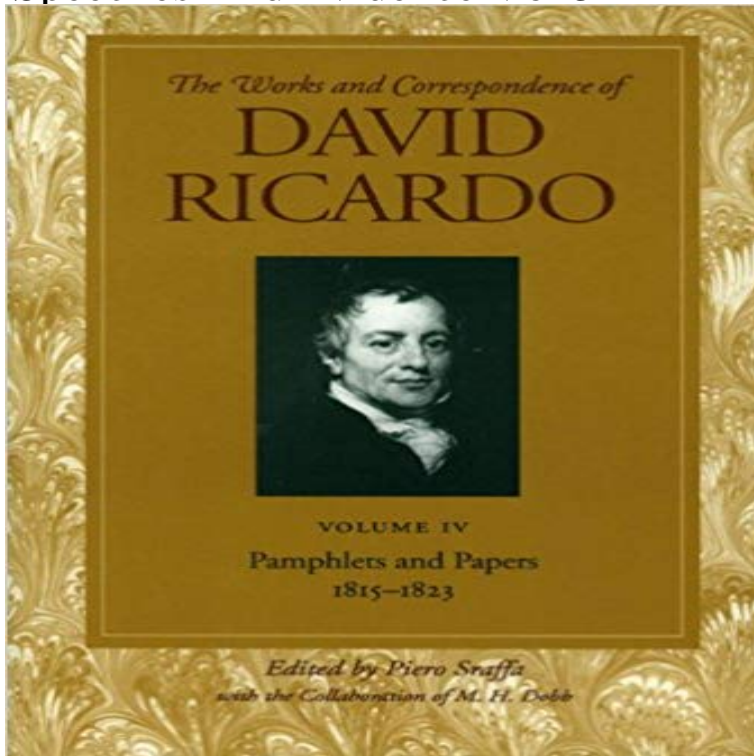


## Speeches And Evidence Vol 5
