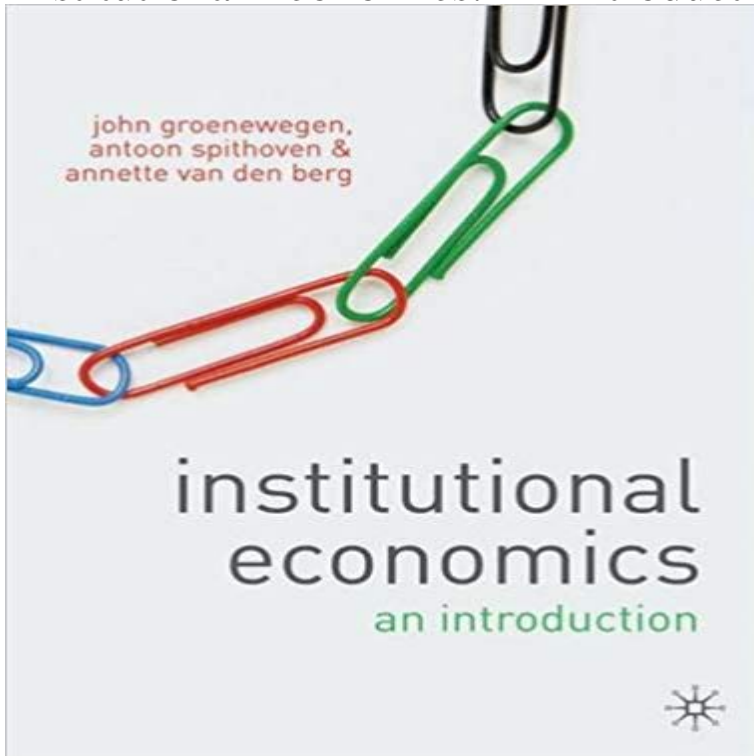


Institutional Economics: An Introduction
