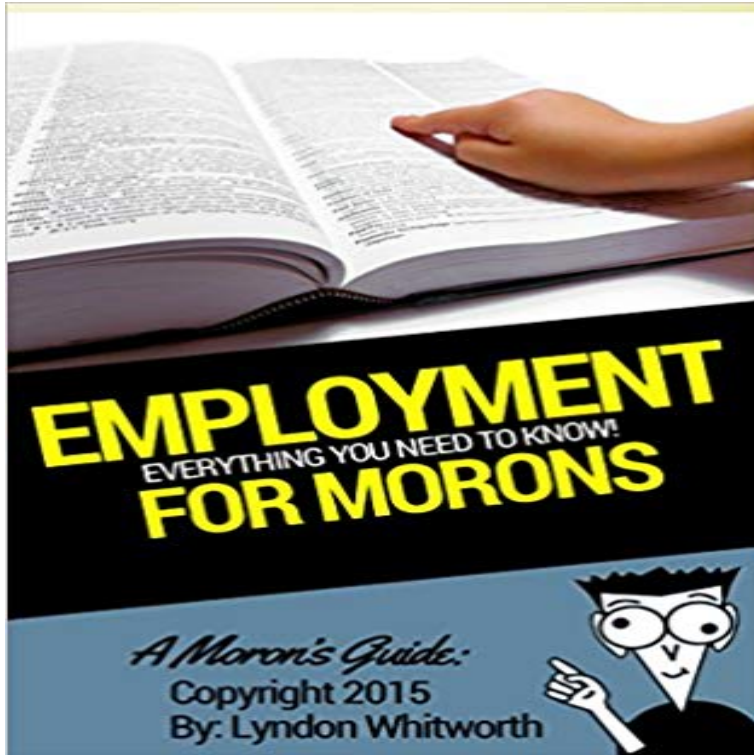


# A Morons Guide to Employment: Resumes, Job Interviews, the Tips and More!
