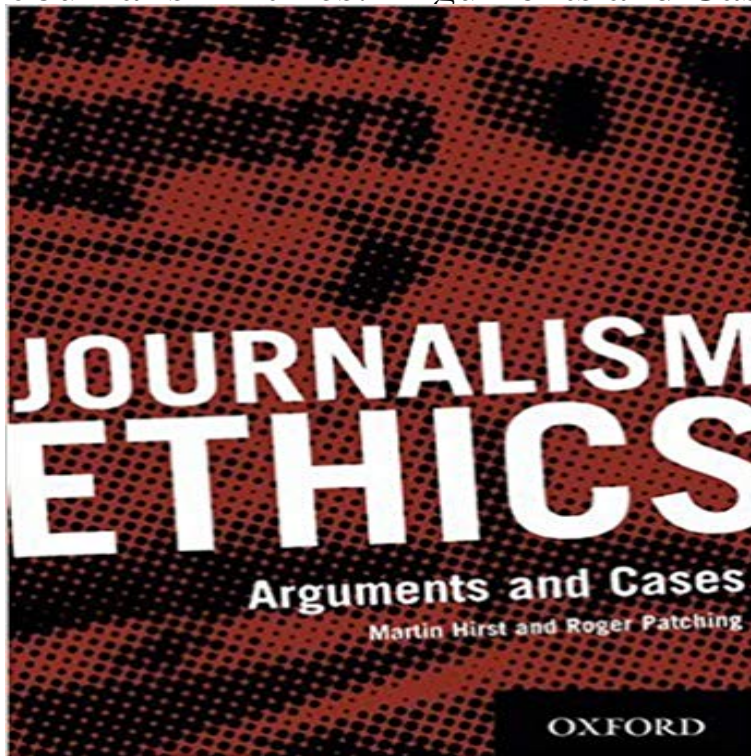


Journalism Ethics: Arguments and Cases
