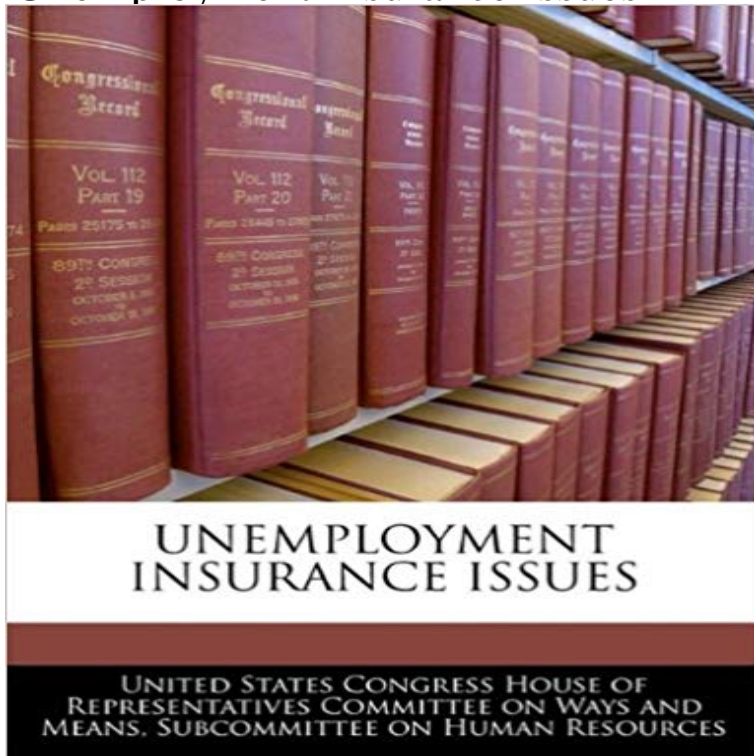


# Unemployment Insurance Issues
