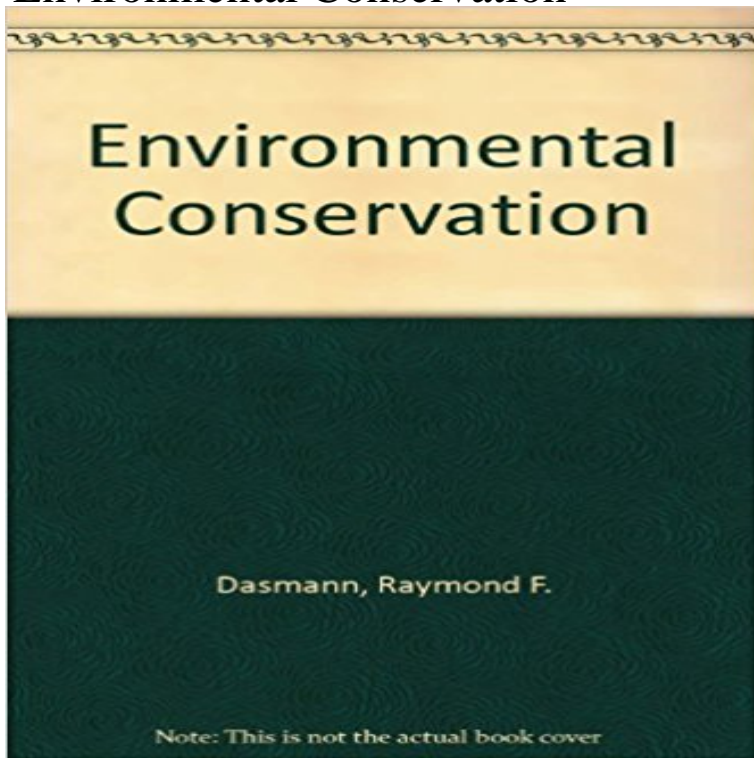


Environmental Conservation
