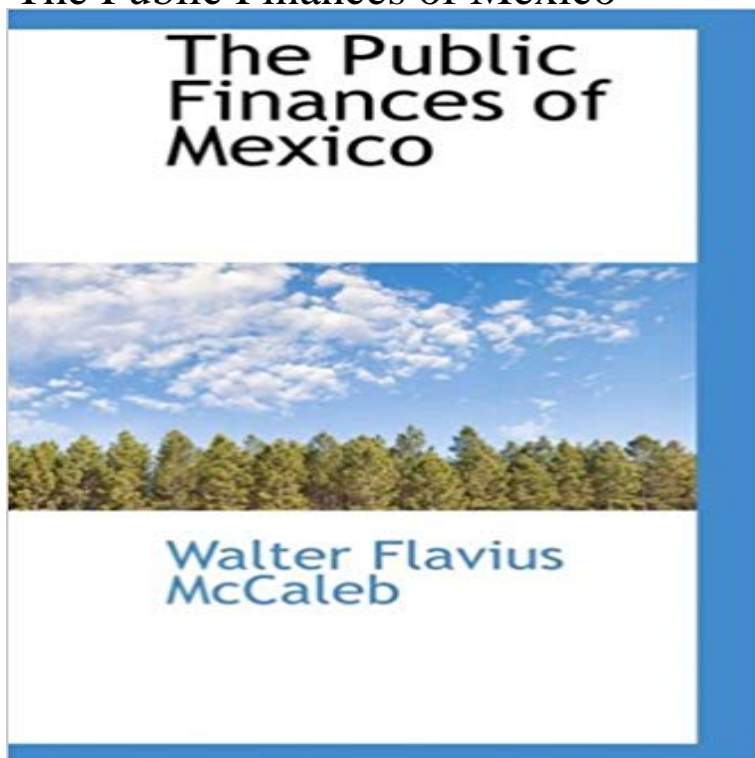


The Public Finances of Mexico
