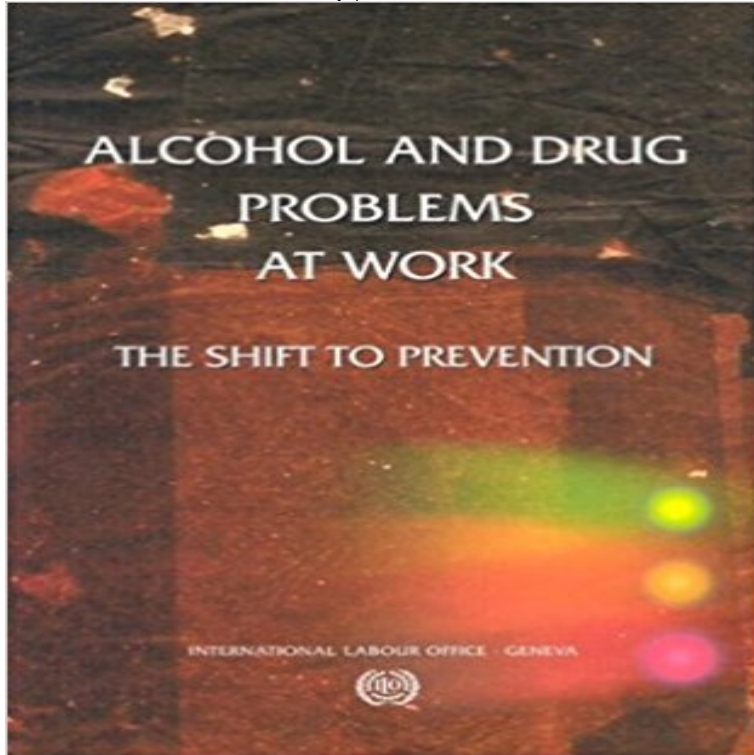


Alcohol and Drug Problems at Work: The Shift to Prevention
