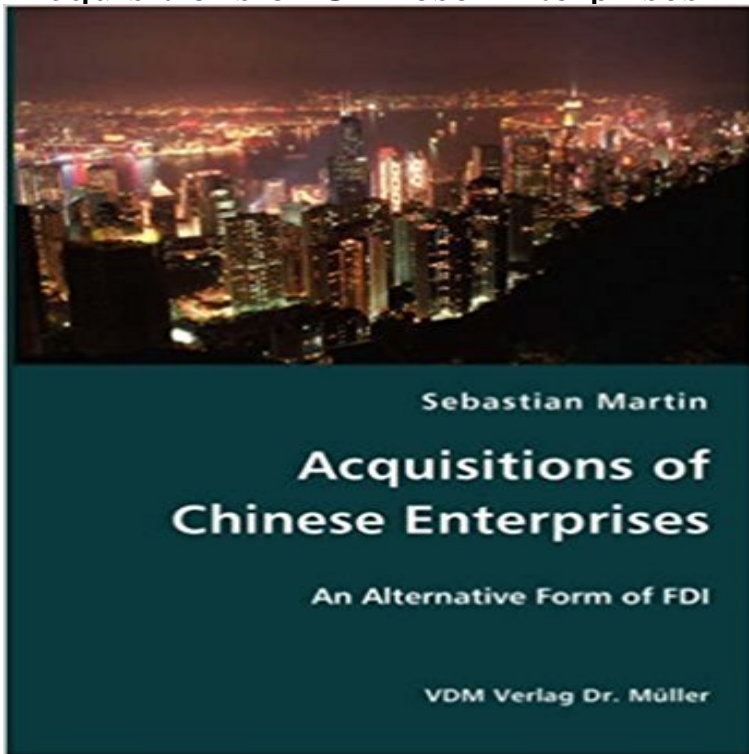


## Acquisitions of Chinese Enterprises- An Alternative Form of FDI
