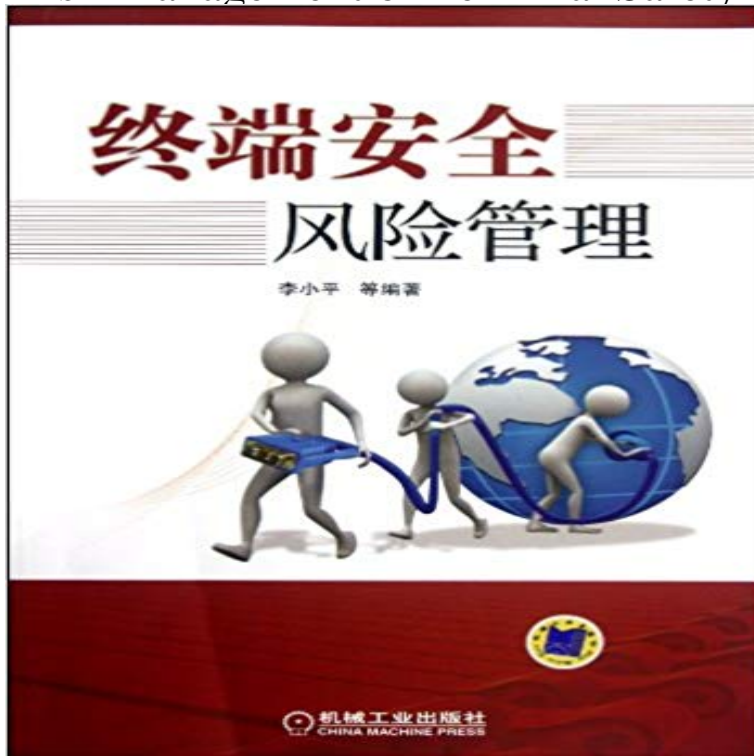


Risk Management of Terminal Safety (Chinese Edition)
