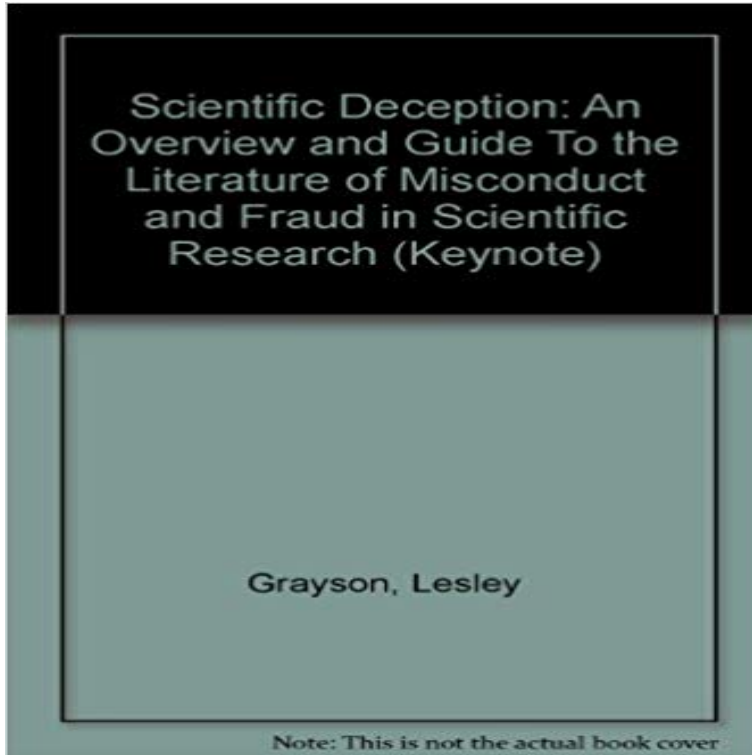


Scientific Deception: An Overview and Guide To the Literature of Misconduct and Fraud in Scientific Research (Keynote)
