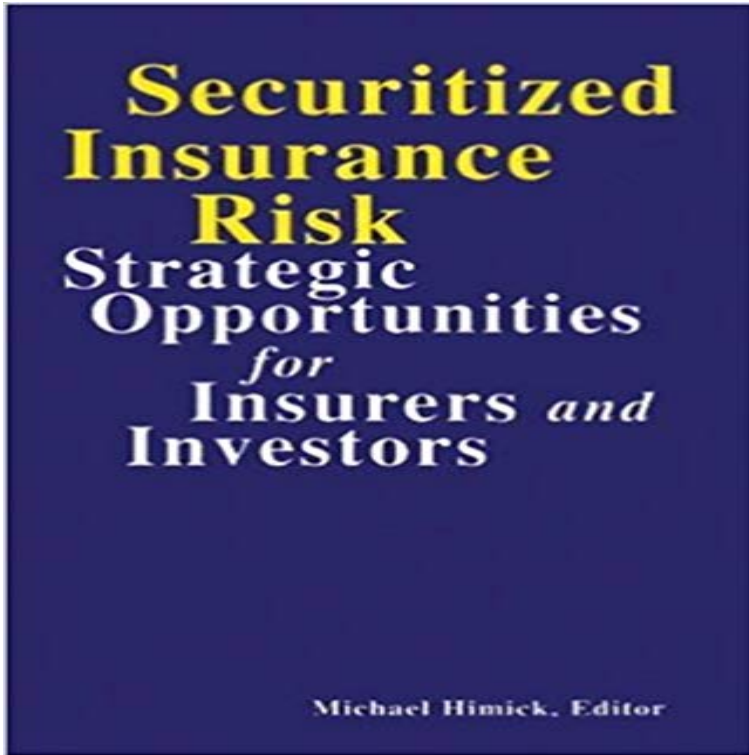


Securitized Insurance Risk: Strategic Opportunities for Insurers and Investors
