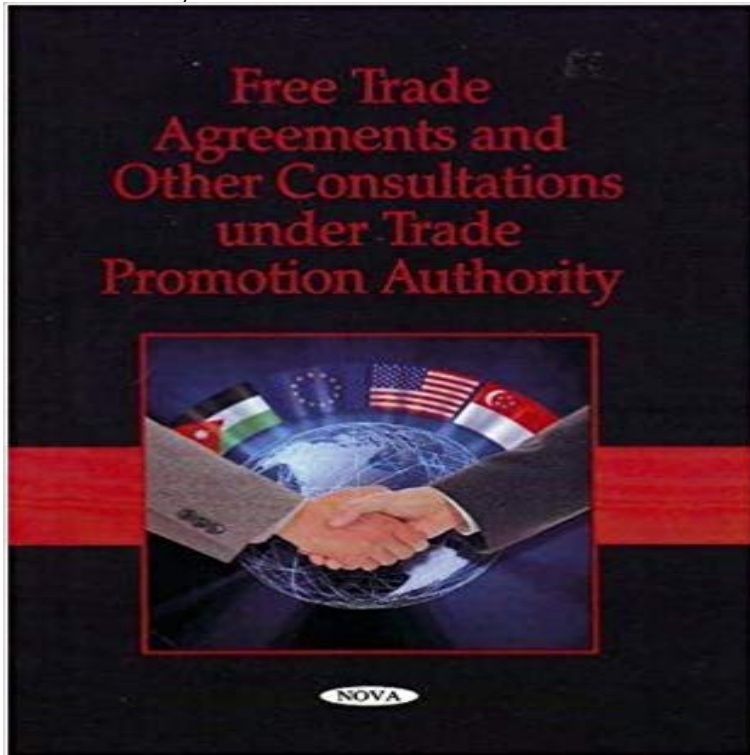


# Free Trade Agreements and Other Consultations under Trade Promotion Authority
