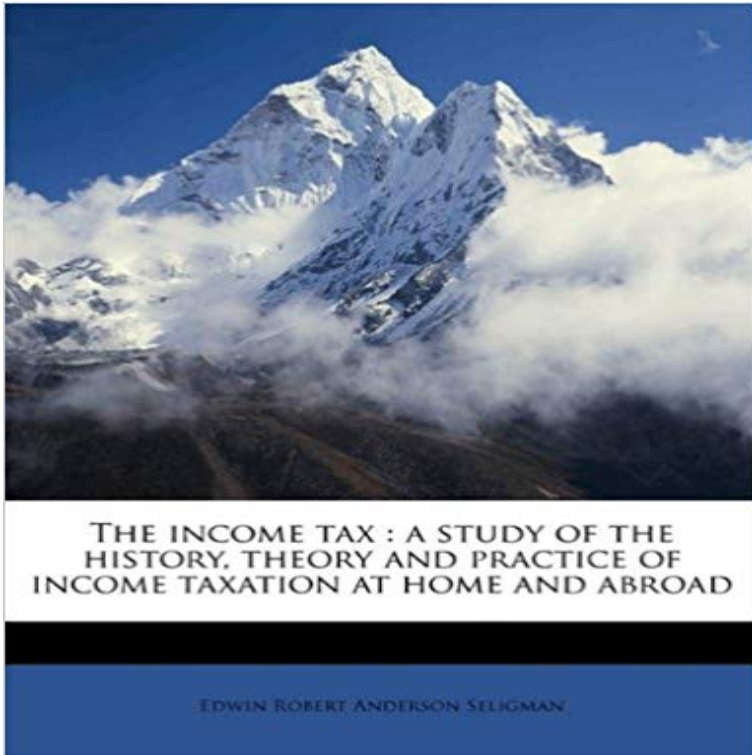


The income tax: a study of the history, theory and practice of income taxation at home and abroad
