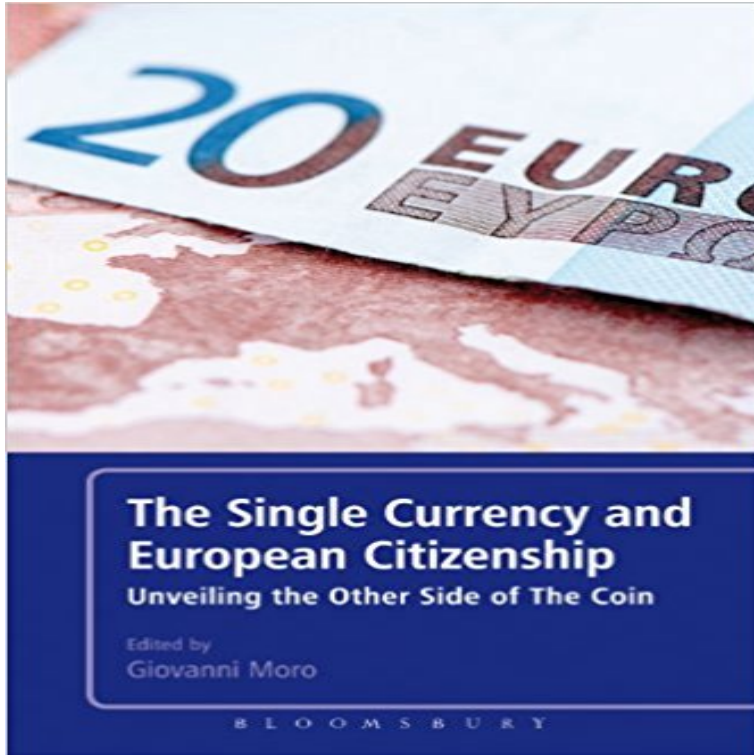


# The Single Currency and European Citizenship: Unveiling the Other Side of The Coin
