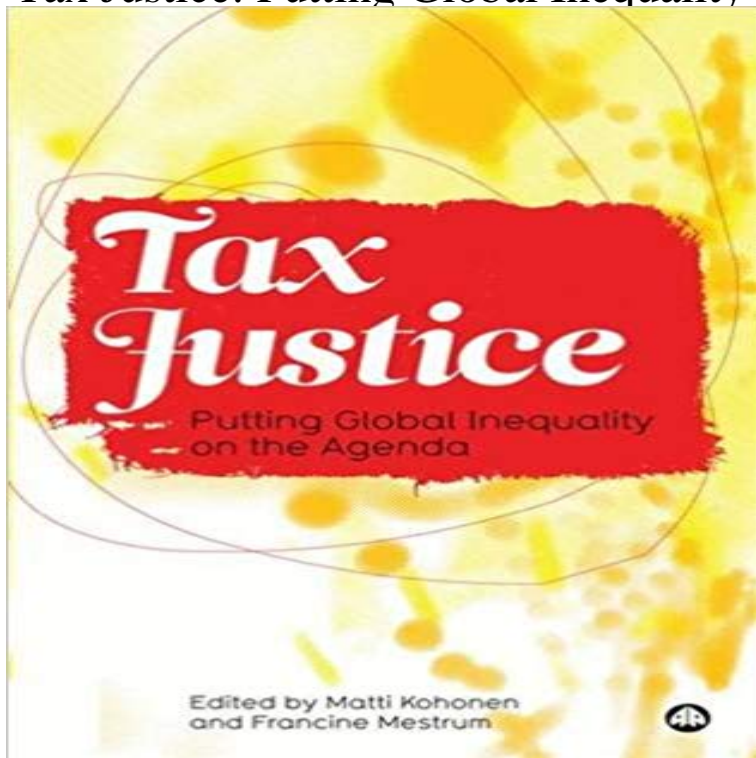


## Tax Justice: Putting Global Inequality on the Agenda
