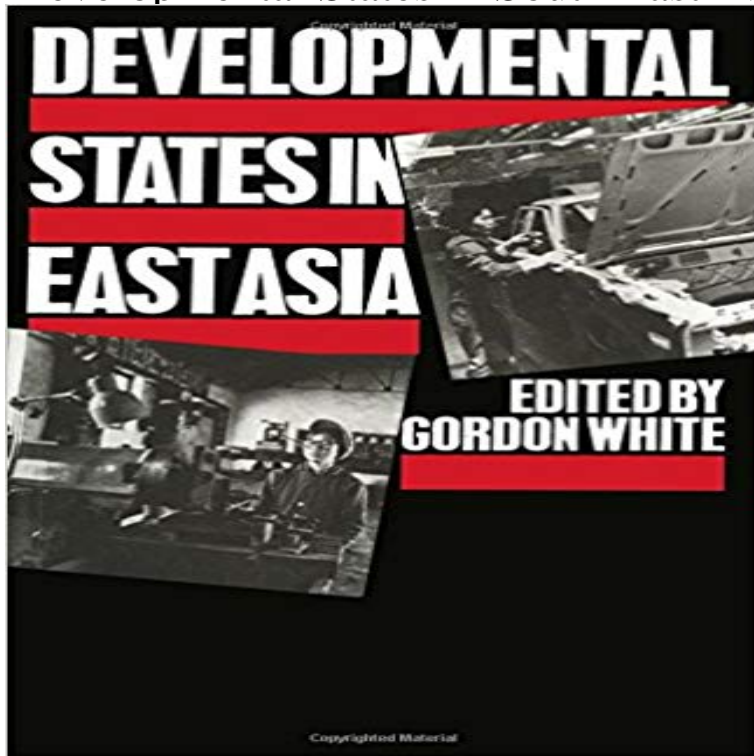


## Developmental States in South East Asia
