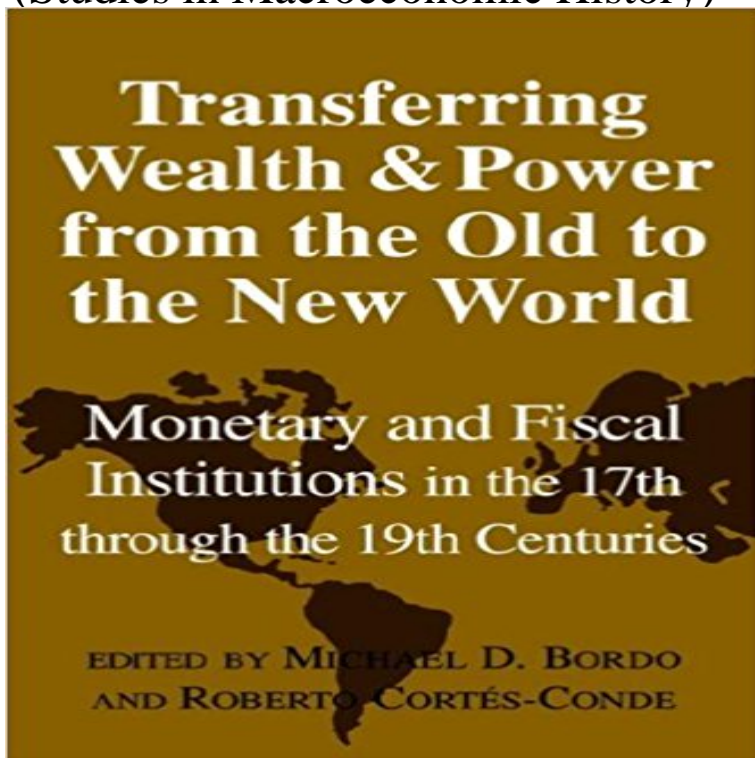

Did the success or failure of the New Worlds institutions in the independent countries reflect the foundations and the flaws of the former colonial masters or adaptation to the new environment?
