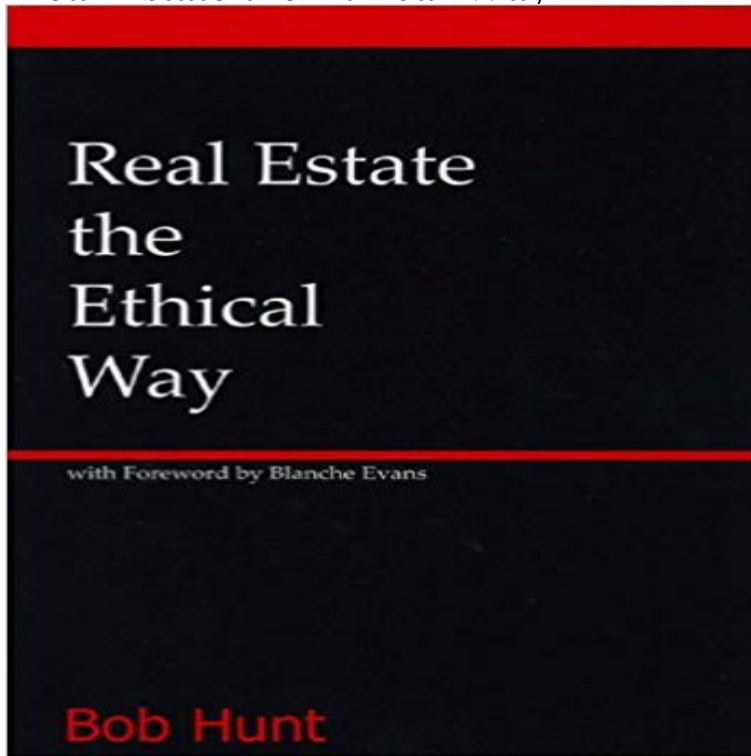


## Real Estate the Ethical Way
