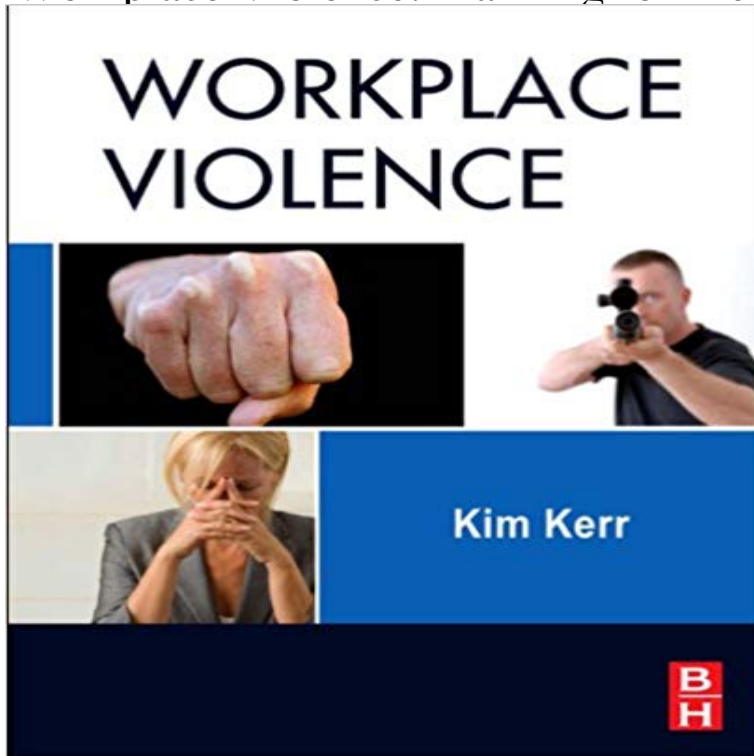


## Workplace Violence: Planning for Prevention and Response
